
Purpose: help the NCW Mobility Council's leadership set priorities and develop the 2021 workplan.

Survey was sent to Mobility Council Members via email in lieu of the December meeting


23 people responded to the survey

- 39% of respondents said they regularly attend meetings and participate in committee work
- 17% occasionally attend meetings

Q6 In your opinion, how valuable is the Mobility Council to our community?




Q7 Do you have any ideas to help the Mobility Council provide greater value to the community?


- Reaching people in the most rural community that have no transit system to use or must travel to get to it.
- This committee's work is important, and the <u>resources shared within the group are essential for someone</u> <u>attending these meetings that are not from the area</u>. I do not know how this group can improve the great work they are accomplishing; I feel the committee covers its bases.
- I think it can be hard to <u>engage individuals with barriers to mobility that don't fall under the low- to moderate</u>

 <u>"social service" kind of bucket</u>. Such as youth or individuals living with blindness, households not on link's line though unable to own/operate personal vehicle, youth, etc. Being able to engage more of the non-social service communities related to mobility-needs would be a great way to expand our work and effectiveness of initiatives.
- Assist with creative ways for rural and remote areas to access transportation
- I think it has been going well
- Continue to provide services especially transportation needs to those in the rural area who do not live within a transit area. T.L.C. provides some rides but just within the Chelan/Manson area
- I think it needs guidance from executives to <u>establish a stronger foundation</u>.
- My only suggestion would be to **encourage participation from more agencies**, perhaps first responders as well.


Q8 The priorities listed below are from the 2018 Chelan-Douglas Human Services

- 23 participants; some new faces but mostly old friends
- Respondents felt the Mobility Council is valuable, but value could be improved by addressing needs of rural communities and those that may be missed by our traditional social service partners
- Our work continues to align with the 2018 HSTP priorities, but could increase impact by focusing on active transportation and rural transportation topics, too
- Priorities for the year ahead include the new volunteer driver program, expanding partnerships and knowledge of local landscape
